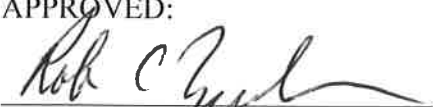
Following the closed session, the meeting was again open to the public. Legal Counsel advised that no reportable action was taken in the closed session.
