2. CHANGES TO AGENDA

4. RESOLUTION 950

The Board will hear reports and may be asked to approve or consider action regarding Resolution 950 designating the District's agent for purposes of the District's request for public assistance from FEMA for the California Severe Winter Storms, Straight-line Winds, Flooding, Landslides, and Mudslides disaster relief.

5. PROPERTY OWNER AUTHORIZATION

The Board will hear reports and may be asked to approve or consider action regarding AERA Energy, LLC's request that the District sign a Letter of Authorization authorizing AERA to apply for a conditional use permit affecting District real property.

The public is provided the opportunity to comment on agenda items at the time those agenda items are discussed by the Board.
